Minutes of meeting – 18th May 2017 following the Annual Parish Meeting.

2. Election of Chairperson

Cllr Dick proposed Mrs Booth and Cllr Mitton seconded this. It was agreed unanimously.

3. Election of Vice Chairperson

Cllr Booth proposed Cllr Herbert and this was seconded by Cllr Mitton. This was agreed unanimously.

4. Minutes of the Parish Council Meeting held on Thursday 20th **April 2017** were accepted and signed. This was proposed by Cllr Mitton and seconded by Cllr Herbert.

5. Matters for Report

Item 8 – Common Land. Cllr Booth explained that she had met with a solicitor who confirmed that it is a very difficult and complex situation. However, he did make some suggestions and she requested that Common Land be placed on the June agenda for discussion.

Cllrs agreed that it was very similar to a previously approved proposal but with additional plans to improve the environmental impact. Cllrs supported the proposal.

b) Outcomes

9. Preferred Sites and Green Spaces Consultation

The removal of the area between Kirkby Lane and Lumley Lane as a Local Green Space was discussed at length. Cllr Booth proposed that the Parish Council should support its reinstatement as it provides a circular route with a public footpath which is a village amenity. This was seconded by Cllr Herbert and agreed unanimously. Cllrs commented that the proposed employment site at Leeming is very large. Concern was expressed that as access from Low Street towards the A1 is already difficult due to the number of lorries blocking the junction this would be exacerbated by further development. Cllrs also commented on the visual impact of further development on the wider area and used the new service area as an example. Built on a hill it is visible from miles around, especially at night. The Councillors asked the clerk to respond accordingly. It was agreed to also add this information to the local news letter to advise residents that if they wished to respond they had until 2nd June to respond.

10. Trees and Stiles

Cllrs have identified 4 trees on Kirkby Fleetham green that are in need of attention. The clerk was instructed to contact Mr Rennison for advice and a quotation.

Three stiles in the Parish are in need of repair. The clerk was asked to contact the Footpaths Officer at NYCC to report these.

11. Any Other Business
